Your affiant obtained a sworn recorded statement from **Jackson** who stated that during his massage and while he was faced down, he heard **main** say, "no not there" and he heard her say it again minutes later. He did not lift his head to see what occurred. He then elaborated that after they got into their vehicle, she disclosed that she was penetrated

He further stated that touching anyone`s vagina would have been unintentional. He is discouraged to work as a masseuse and now understands why other Massage facilities

put higher restrictions.
