**Probable Cause Affidavit**

Before me this date personally appeared SONN, ALYSSA (17764) who being first duly sworn deposes and says that on 22 day of March, (year) 2025 at 1201 S OCEAN BLVD 4, POMPAÑO BEACH, FL 33062 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

beds. [REDACTED]'s masseuse was a female, [REDACTED]'s was a male (positively identified as Anil Nayar via a double-blind photo lineup. Anil Nayar will herein be referred to as "the defendant" who is also the business owner).

As [REDACTED] and [REDACTED] were faced down in their separate beds, the defendant rolled up the sheet to massage [REDACTED]'s leg. [REDACTED] stated that the defendant was "very handsy". The defendant massaged up her thigh and then continued to touch the "lips" of her vagina, (labia majora) with his bare finger. [REDACTED] immediately stated "no I'm good" because she was worried about this Spa possibly one of those "happy ending" massage places.


Approximately 5-10 minutes later, the defendant was massaging her leg (she does not remember if he switched legs) and again went up her thigh but this time she felt a finger penetrate her vagina approximately halfway. She sternly stated, "I am good, please focus on my feet!". [REDACTED] stated that the incident lasted approximately a "split second". The defendant then massaged her feet like she requested and prior to finishing the massage, lifted her shoulders until her face and breasts were exposed which she was also uncomfortable with.

As they finished the massage, she asked [REDACTED] "were they kind of handsy?" and further asked him if this was one of those "happy ending" places.

Your affiant obtained a sworn recorded statement from [REDACTED] who stated that during his massage and while he was faced down, he heard [REDACTED] say, "no not there" and he heard her say it again minutes later. He did not lift his head to see what occurred. He then elaborated that after they got into their vehicle, she disclosed that she was penetrated

Before me this date personally appeared SONN, ALYSSA (17764) who being first duly sworn deposes and says that on 22 day of March, (year) 2025 at 1201 S OCEAN BLVD 4, POMPAÑO BEACH, FL 33062 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows.

by the defendant's finger. [REDACTED] also stated that after the incident, [REDACTED] has started to "spiral", and they are both very upset. [REDACTED] stated that they have not had intercourse since prior to this incident occurring.

[REDACTED] stated that he wanted to go back to Red Rose and "beat" the defendant but kept his composure. A double-blind photo lineup was completed by Deputy Santiago Ferrufino CCN 20067 independently with [REDACTED] and [REDACTED], both made positive identifications.

The defendant was taken to the BSO Pompano district office by Deputy Daniel Danley CCN 21091. Post Miranda, the defendant agreed to speak with me. He stated that he does not remember which client in question, however walked me through his massage routine. He is the owner of the facility and is very passionate about his profession. He "goes where the muscle takes him" which could mean more thorough massages for his customers. Some thigh muscles that may be stiff for some, he will go higher up the inner thigh muscle. He does not have cameras in any of the rooms, only one at the point of entry

The defendant stated that there is a possibility that he may have touched or grazed the vaginal "lips" because he is working high on the inner thigh and the body is oily, however, to penetrate with his finger would be impossible. He further stated that touching anyone's vagina would have been unintentional. He is discouraged to work as a masseuse and now understands why other Massage facilities put higher restrictions.

The defendant was arrested for one count of sexual battery and transported to BSO Main Jail.


