BEFORE ME THIS DATE PERSONALLY APPEARED, DET. N. RATLIFF #1180, WHO BEING FIRST DULY SWORN DEPOSES AND SAYS THAT BETWEEN 2023 AND ON 11th DAY OF NOVEMBER, 2025 AT 6941 SW 196TH AVE UNIT 12 PEMBROKE PINES, FL, BROWARD COUNTY, THE ABOVE NAMED DEFENDANT COMMITTED THE ABOVE OFFENSES CHARGED AND THE FACTS SHOWING PROBABLE CAUSE TO BELIEVE THE SAME ARE AS FOLLOWS:

On November 17, 2025 [REDACTED] and her parents arrived at the Pembroke Pines Police Station to report their daughter being involved in a sexual relationship with an adult acquaintance, Rakesh Jhaveri (DEFENDANT).

[REDACTED] father had found an explicit conversation between the defendant and [REDACTED] on her laptop via the Discord application.

The investigation revealed that the victim and the suspect are family friends. The victim met the defendant when she was approximately eight years old.

Approximately two years ago, 2023, the victim (then 13) commenced music lessons with the defendant at a music studio in [REDACTED]

In October of 2023, [REDACTED] stated she kissed the defendant for the first time. After a few months, the kissing escalated to digital penetration. After a few months of digital penetration, they escalated to vaginal penetration. [REDACTED] recalled the defendant not using any sort of protection during their first intercourse. After their first sexual intercourse, the defendant started using condoms and continued using condoms every time they had sexual intercourse.

[REDACTED] stated most of their intercourse occurred at [REDACTED] where the defendant was allegedly teaching her music lessons.

Contact was made with the defendant at his residence where he stated that he told his wife that he was recently texting a young female.

The defendant then wished for privacy, and the conversation continued in my unmarked vehicle.

The defendant stated that he did in fact engage in sexual activity with the victim between the ages of 13 and 15. He stated it started as kissing in Fall of 2023. By Spring 2024, their relationship escalated to physical touching and then in 2025, they were mostly engaging in sexual penetration to which he estimated occurring between five and ten times.

The defendant stated he would message the victim via Discord to assist her with any troubles she was experiencing.

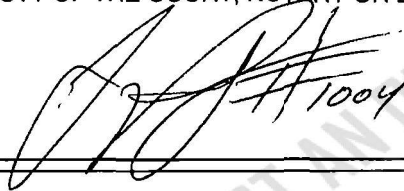
