

THE VICTIM IS A 29-YEAR-OLD FEMALE, AND THE DEFENDANT IS A 63-YEAR-OLD MALE. THE VICTIM IS A PATIENT OF THE DEFENDANT.

THE VICTIM STATED THAT ON SATURDAY, OCTOBER 25, 2025, AT APPROXIMATELY 1420 OR SO HOURS SHE HAD A FOLLOW-UP APPOINTMENT TO SEE THE DEFENDANT (DR. RONALD F. DEMEO) LOCATED AT THE INCIDENT LOCATION (2801 SW 3RD AVE 3RD FLOOR MIAMI, FL-DADE COUNTY) FOR A COSMETIC PROCEDURE. VICTIM STATED THAT SHE RECALLS INHALING "NITRO." A SEDATIVE TO ALLEVIATE PAIN BEFORE THE PROCEDURE ALONG WITH PRESCRIBED MEDICATION. VICTIM STATED THAT WHILE WAITING FOR THE DEFENDANT TO COME INTO THE PROCEDURE ROOM A STAFF MEMBER OFFERED HER A GLASS OF WINE (SOMETHING THATS USUALLY PROVIDED TO PATIENTS) AND SHE ACCEPTED IT. THE VICTIM FURTHER STATED THAT SHE RECALLS SEEING THE DEFENDANT IN THE ROOM AND HEARING HIM TELL HER THAT HE WOULD SEE HER IN A WHILE AND TO INHALE NITRO PRIOR TO HIM RETURNING. THE VICTIM STATED SHE REMEMBERS CONTINUING TO INHALE NITRO, THE DEFENDANT BEING IN THE ROOM AND CLOSING THE BLINDS IN THE ROOM. SHE RECALLS FEELING AS IF SHE WAS PUSHED DOWN IN WHAT SHE THINKS WAS AN OFFICE, THEN OPENING HER EYES, AND SEEING THE DEFENDANT OVER HER BODY AS HE WAS PENETRATING HER PENILE/VAGINAL. THE VICTIM STATED SHE DID NOT HAVE THE STRENGTH TO SPEAK OR FIGHT BACK AND JUST CLOSED HER EYES WANTING THE ASSAULT TO END. THE VICTIM STATED SHE FELT IMPAIRED, HAVING NO CONTROL OF HER BODY. VICTIM STATED SHE NEVER CONSENTED TO, DISCUSSED OR EXPRESSED ANY INTEREST IN THE DEFENDANT OR ENGAGING IN ANY SEXUAL ACTIVITY. THE VICTIM STATED SHE RECALLS LOOKING FOR HER PANTS, WALKING OUT OF THE OFFICE, AND NOT SEEING STAFF MEMBERS. A FEW DAYS LATER THE VICTIM STATED THAT SHE WAS GOING THROUGH HER CELL PHONE AND LOCATED A VIDEO WHICH RECORDED THE DEFENDANT SEXUALLY ASSAULTING HER.

NOTE: I OBSERVED THE VIDEO (EVIDENCE) AND CONFIRMED THE IDENTITY OF THE VICTIM ALONG WITH THE DEFENDANT. NON CONSENSUAL SEXUAL ACTS & GESTURES WERE OBSERVED.

ON WEDNESDAY, MARCH 18, 2026, AT APPROXIMATELY 2050 HOURS, DETECTIVE A. COELLO #45308 FROM THE FELONY APPREHENSION TEAM LOCATED THE DEFENDANT AT THE INCIDENT LOCATION, 2801 SW 3RD AVE AND TOOK THE DEFENDANT INTO CUSTODY.

AT APPROXIMATELY 2137 HOURS, I INTRODUCED MYSELF TO THE DEFENDANT AND EXPLAINED THAT I HAD A SEARCH WARRANT TO EXECUTE AT THE INCIDENT LOCATION AND WAS REQUESTING ACCESS TO ANY ENTRY DOOR SO HAT NO DAMAGE CAME TO THE PROPERTY IF NOT NECESSARY. THE DEFENDANT STATED THAT HE WOULD CALL THE PROPERTY MANAGER AND HAVE HER RESPOND. THE DEFENDANT WAS GIVEN ACCESS TO HIS CELLULAR PHONE TO MAKE THE PHONE CALL. AN ATTEMPT WAS MADE WITH NEGATIVE RESULTS IN THE PERSON ANSWERING. THE DEFENDANT STATED THAT HE WOULD CALL SOMEONE ELSE AND CONTACTED A MALE WHO LATER IDENTIFIED HIMSELF AS THE DEFENDANTS ATTORNEY (NAME PROVIDED BY DEFENDANT-PHIL ROTHSTEIN). MR.
