On October 7, 2021, I responded to 2100 High Ridge Rd, in unincorporated Lake Worth, Palm Beach County, FL. in reference to a battery investigation. The incident occurred on October 5, 2021, at 6677 Boynton Beach Blvd, Boynton Beach, FL, 33437 (Hand & Stone Massage and Facial Spa). I met with the victim, Allison Soto.

Soto stated the following, on Tuesday, October 5, 2021, at 1700 hours she arrived at Hand & Stone Massage and Facial Spa for her massage appointment. She met with Christian, who advised he was going to do her massage. When they went to the room, he asked what area she wanted massaged and she stated her back. He asked her which areas she wanted him to avoid and she stated her glutes.

He began to massage her back and later began to massage her glutes area above the drape that was used to cover that area. Soto advised he later asked, "that shit feels good, don't it?" She replied yes, thinking he was talking about the back massage and not her glute massage. She stated focused more on her thigh and glute area more than her back. She advised she got tense, and uncomfortable but did not say anything else. She noticed, she had a drape cover by her vagina area that was moved. Unknown how or when it was moved during her massage. Soto then felt his hands spread her thighs outwards and one of the hands touched her vagina labia. She advised she said "stop" and quickly closed her legs. Soto advised he said sorry and continued with the massage. Soto stated she knew she should have left but described her feeling as nervous, scared, and just shocked. She stated there was no penetration. After the massage, she advised she went to the bathroom and noticed her underwear pushed to the side.

At approximately 2235 hours, Deputy K. Noel ID# 7660, conducted a photo lineup in which Soto reviewed and positively identified the defendant in this case, Christian Mieleles. The photo was signed, initialed, and dated by Soto. The signed photo array was submitted into evidence.

I met and spoke with the defendant, Christian Mieleles, on October 12, 2021. Mieleles was read his Miranda rights, advised he understood and was willing to cooperate. He advised she went in for a full body massage. I questioned him if she was ever asked which areas to avoid and he believes he remembers she wanted the glute area to be avoided. I asked Mieleles if he recalled massaging her glutes and he stated yes even though it was mentioned not to massage that area. I advised Mieleles that Soto is alleging that he spread her legs and he touched her vagina. He stated that he did not believe that he grazed that area. He advised if he did touch that area, it was a mistake. He stated he did hear her say stop when he massaged the thigh area, said sorry, and continued to massage her. She did not ask him to stop the massage. No video surveillance or witnesses.

Based on the above facts, I found Probable Cause exists to arrest Christian Mieleles for Battery pursuant to FSS. 784.03(1a1).
