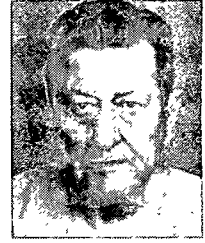

Before me this date personally appeared RIVERA, ANDRES E. (20115) who being first duly sworn deposes and says that on 23 day of October, (year) 2022 at \_\_\_\_\_ (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

\_\_\_\_\_ 's vagina while \_\_\_\_\_ suffered from the mental defect of Alzheimer's Disease and dementia, and Guillermo Llanos had reason to know or had actual knowledge of said mental defect, contrary to F.S. 794.011(4) (e), (L).

\_\_\_\_\_ and Llanos both reside at the Assisted Living Facility at the above location. Llanos resides in room 132 and \_\_\_\_\_ resides in room \_\_\_\_\_, in different wings of the facility. Llanos is familiar with \_\_\_\_\_ and knows that she has sever dementia. At approximately 1150 hours, Llanos entered the private room of \_\_\_\_\_ and pulled down her adult diaper to her mid-thigh. \_\_\_\_\_ began to yell "No" and for Llanos to "stop." At that time, the staff member stationed nearby, \_\_\_\_\_ heard \_\_\_\_\_'s cries and responded to investigate. he found \_\_\_\_\_ with her diaper midway down her thigh and later admitted that he tried to assist her by pulling it up, but continued to lie to Detective Rakofsky and said that he did not touch \_\_\_\_\_'s vagina. Llanos later admitted that he may have touched \_\_\_\_\_'s vagina as he was trying to "assist" \_\_\_\_\_. Sworn statements were also captured from \_\_\_\_\_ and \_\_\_\_\_.

During the investigation, a report taken by the Palm Beach County Sheriff's Office in April of 2021 was discovered, in which Llanos was caught engaging in a sex act with a mentally defective resident at his last assisted living facility residence. That report is included herein, verbatim, as follows:

"ON 04/25/2021, AT APPROXIMATELY 0230 HOURS, I RESPONDED TO HEARTLANDSENIOR ASSISTANCE LIVING LOCATED AT 7225 BOCA DEL MAR DRIVE, BOCA RATON, FLORIDA 33433, IN THE UNINCORPORATED BOCA RATON/ PALM BEACH COUNTY, FLORIDA, IN REFERENCE TO A POSSIBLE ELDERLY SEXUAL ASSAULT. WHILE EN-ROUTE, PBSODISPATCH ADVISED THE COMPLAINANT, THE FACILITY'S NURSE, STATED SHE WITNESSEDDONE OF HER FEMALE PATIENTS, LATER IDENTIFIED AS \_\_\_\_\_ (77 YEARSOLD), NAKED ON THE BED WITH ANOTHER MALE PATIENT LATER IDENTIFIED AS GUILLERMOLLANOS. UPON ARRIVAL, I MADE CONTACT WITH THE COMPLAINANT, \_\_\_\_\_, WHO ADVISED SHE WALKED INTO \_\_\_\_\_'S ROOMS AND SAW GUILLERMO ON TOP OF \_\_\_\_\_ MAKING MOVES AS THEY WERE PERFORMING A SEXUAL ENCOUNTER. \_\_\_\_\_ ADVISED THEY WERE NAKED, AND GUILLERMO DID NOT APPEAR TO HAVE A PENIS ERECTION. \_\_\_\_\_ ALSO ADVISED \_\_\_\_\_'S LEGS WERE NOT SPREAD APART WHILE GUILLERMO WAS ON TOP OF HER. \_\_\_\_\_ ADVISED SHE YELLED, "WHAT'S GOING ON," WHICH GUILLERMO JUMPED OUT OF BED AND PUT ON HIS ROBE. \_\_\_\_\_ ADVISED SHE ESCORTED GULLERMO BACK TO HIS ASSIGNED ROOM AND CALLED 911 TO REPORT THE INCIDENT. \_\_\_\_\_ STATED SHE DID NOT WITNESS A PENETRATION. SHE ASSESSED \_\_\_\_\_, WHO HAD NO APPARENT SIGNS OF ABRUISE ON HER WRIST, ANY PART OF THE BODY, INCLUDING \_\_\_\_\_'S VAGINA.

I ASKED \_\_\_\_\_ A SEVERAL QUESTIONS TO DETERMINE IF THE ENCOUNTER WAS CONSENSUAL OR IF A SEXUAL BATTERY HAD OCCURRED, SUCH AS "DO YOU HAVE A BOYFRIEND" "DID YOU INVITE SOMEONE TO SLEEP ON YOUR BED." "DID YOU SEE A NAKED MAN?" \_\_\_\_\_ WAS UNAWARE OF HER SURROUNDINGS AND KEPT ANSWERING NO TO ALL MY QUESTIONS. \_\_\_\_\_ DID NOT KNOW WHERE SHE WAS NEITHER DID SHE KNOW WHO THE U.S. CURRENT PRESIDENT WAS. \_\_\_\_\_ WAS UNABLE TO DETERMINE IF IT WAS CONSENSUAL DUE TO HER MENTAL HEALTH CONDITION. AT APPROXIMATELY 0630 HOURS, I RECEIVED A CALL FROM THE HOSPITAL'S ADVOCATE TEAM ADVISING THAT THEY WERE NOT PERFORMING ANY SEXUAL ASSAULT SCREENING WITHOUT A REQUEST FROM A DETECTIVE.
