In Manatee County, between the dates of 04/26/2024 through 06/25/2024, the defendant, Jonathan Edward Elwing, did violated FSS 794.011(2)(A) Capital Sexual Battery, FSS 827.071(2) Production of Child Pornography, and FSS 827.071(5)(A) Possession of Certain Images of Child Pornography based on the following information. A search warrant was executed for the residence of [REDACTED] on 06/21/2024. Contact was made with a Jonathan Elwing by Det. Steven Luke and Det. Carmine Luper of the Manatee County Sheriff's Office. Det. Luper advised Jonathan that he had a few questions for him, that he did not need to answer if he did not wish to, but he would like to verify some information. Jonathan verified his full name to be Jonathan Edward Elwing and his date of birth to be 04/12/1981. Jonathan additionally advised that he would be willing to provide the passcode to his electronic devices if law enforcement wanted them. Jonathan also mentioned multiple electronic devices that he utilized. When asked if Jonathan had a cellphone, he stated that he did, and it was in his residence. Jonathan was advised that law enforcement had a search warrant for the residence that we would be executing. He was then asked if he had anything on his person, to which he felt in his pockets and procured his wallet and a cellphone, among other items. Jonathan advised that the cellphone he removed from his pocket was his personal cellphone. Jonathan was then read a copy of the search warrant. Jonathan was read his Miranda rights and he advised that he would be willing to speak with Law Enforcement. Jonathan stated that he was the only person that uses his phone and no one else has access to it. During this interview Jonathan provided the passcode to his electronic devices. The passcode that was provided by Jonathan, was the passcode utilized to gain access to the cellphone that Jonathan removed from his pocket and stated was his. Additionally, Jonathan said that he would sometime purchase adult pornography from a third-party person, and it is possible that child pornography would be part of the purchase, without his knowledge. Jonathan advised that he deleted any of those images/videos of child pornography that may get mixed in. Jonathan also advised that there would be no child pornography on his devices because he does not look at child pornography and he would delete anything he saw that he might consider to be child pornography when he was looking at adult material. Jonathan did not wish to speak about the adult material that he would look at. While speaking with Jonathan he confirmed that his cellphone was a Google Pixel 7. During the execution of the search warrant, an on scene forensic extraction of Jonathan's cellphone was completed. Based on the extraction completed on scene multiple items of evidentiary value were located. Four of the items located depicted Child Sexual Abuse Material (CSAM). It was determined that, with Jonathan's consent; he would be brought to MCSO District 2 and brought into an interview room for further investigation. On scene Jonathan was asked if he would be willing to come back to the office for an interview and he stated that he would. Jonathan was transported back to the district, by myself and Det. Luper through an agency issued vehicle, where he was placed into an audio and video recorded interview room. During the interview Jonathan, he advised he had four children, and the [REDACTED] was identified as being [REDACTED] with a date of birth of [REDACTED]. Jonathan signed a Warning of Constitution Rights form, advising he would be willing to continue speaking with law enforcement. The interview began and when Jonathan was confronted with the images of CSAM located on his cellphone, he advised that he needed a lawyer. At this point the interview stopped, and Jonathan was placed under arrest for 4 counts of a violation of F.S.S. 827.071(5)(a) Possession of Content Depicting the Sexual Performance of a Child. On 06/25/2024, I conducted a full filesystem extraction of Jonathan's Google Pixel 7 Pro. While reviewing the extraction in Cellebrite Physical Analyzer, 6 images that depict CSAM were found. Of those images, Image b6a7fae1693a40e69a78fb60c7f72bd/PHOTO showed Jonathan's face while he had a minor child sitting on top of his erect penis. The minor child's face was not visible in any of the 6 images, but she was wearing a distinct shirt that had a picture of a cartoon giraffe and writing on the side of the giraffe. Also visible in the images was a distinct blue bedding that the child and adult were observed on top of. Based on the information observed, the minor child appeared to be [REDACTED] of Jonathan. Sanitized images were shown to [REDACTED] who was able to identify the shirt observed in the images. The shirt showed two cartoon giraffe's and on the side of the giraffe was the writing, "Mama's Mini". The shirt was identical to the shirt observed in the images. The shirt was collected as evidence at which time it was confirmed as the one the victim was wearing at the time of the incident. Pictures of the blue bedding which was observed in the images was compared to the Crime Scene photos taken during the execution of the residence search warrant for Jonathan's residence on 06/21/2024. The blue bedding was an exact match to the Crime Scene photos which were taken from the master bedroom of Jonathan's residence. While viewing the 6 images found on Jonathan's Google Pixel 7 Pro, utilizing Cellebrite Physical Analyzer, the images had a capture date of 04/26/2024 and were taken between the times of 4:17:23 through 4:21:06 PM EST. The Camera Make was Google and Camera Model was a Pixel 7 Pro which is the same make and model camera that Jonathan was in possession of. Based on the information obtained, I believe there is probable cause to charge Jonathan Edward Elwing with 2 counts of Capital Sexual Battery, 6 counts of Production of Child Pornography, and 6 counts of Possession of Certain Images of Child Pornography.
